REPORT OF THE TRUSTEES

FOR THE YEAR ENDED 31 DECEMBER 2004

The Trustees present herewith their report along with the financial statements of the charity for the year ended 31 December 2004.

The Society registered as a charity on 25 April 1975 under registration number 266383.

The Society is affiliated to the Richard Wagner Verband, the International Organisation of Wagner Societies.

Principal objectives

The principal objectives of the charity are as follows:-

- 1) To advance education in and appreciation of the life and work of Richard Wagner.
- 2) To promote and organise public performances anywhere in the world of the works of Richard Wagner by the Society from time to time and for special purposes include in its programmes suitable works by other composers.
- To promote and organise other cultural and educational activities relevant to the study and appreciation of the music of Richard Wagner.

Policies adopted

To achieve the above policies the Society:-

- Arranges meetings, events and study days to enable members to further their understanding and appreciation
 of the life and works of Richard Wagner. It also arranges events at which singers, directors, conductors etc.
 of Wagner productions talk about and discuss their work.
- 2. Publishes at regular intervals two magazines, Wagner and Wagner News, that are distributed free of charge to members.
- Provides financial help to fund the coaching of young singers of Wagner and provides a bursary to enable a
 young singer to visit Bayreuth each August.
- 4. In association with organisations such as The Mastersingers Company provides opportunities for young singers to perform Wagner in public and to take part in competitions.

Review of activities for the year 2004

During 2004 the Society presented a varied programme of events and meetings. These included the showing of a laserdisc recording of the Herbert von Karajan film of **Das Rheingold**; interviews with Phyllida Lloyd, Paul Daniel and Keith Warner; a study day on Wagner and Elgar; talks by Neil Howlett (What is a Heldentenor?) and Terry Edwards (The role of the chorus in Wagner's operas); a recital by Susan Bullock with Lionel Friend at the piano at St James's Church, Piccadilly; a recital by Amanda Echalaz after the AGM in May; a Reginald Goodall nostalgia evening with Dame Anne Evans, Derek Hammond Stroud, Lionel Friend, Richard Fisher and Andrew Porter; and a Society dinner in December at which the guest was Graham Clark.

These events have been organised by Jeremy Rowe, who took over as Programme Director at the beginning of the year, with the assistance of Gary Kahn.

Recordings have been made of selected meetings and the CDs are available from the Programme Director.

The Society has continued to support young artists through financial help to pay for coaching and also, in collaboration with the Mastersingers, has enabled them to take part in live performances. In September past winners and finalists of the Bayreuth Bursary competition took part in a Wagner and Berlioz presentation which included all the songs written by Richard Wagner including his seldom performed early ones. In October singers from the Young Artists Programme took part in a concert performance of **Die Walküre** Act III with the Rehearsal Orchestra. This was repeated in a fully staged performance, with piano accompaniment by Kelvin Lim and conducted by Tony Legge, as part of the Sunday Afternoon with Wagner event at the Duke's Hall of the Royal Academy of Music in December.

The 2004 Bayreuth Bursary competition was held on a Sunday afternoon in January at the Duke's Hall of the Royal Academy of Music. The six finalists were accompanied by Mark Packwood at the piano and performed before a distinguished panel of judges and a large and enthusiastic audience. The winner was Claire Weston and the Society paid for her to visit Bayreuth in August to see three performances at the Festspielhaus.

Wagner (editor Roger Allen) was published twice in 2004 and Wager News (editor Ian Beresford Gleaves) six times. The Society web site (www.wagnersociety.org) has been developed by Ian Jones and now contains full information about the Society and its activities.

Financial review and investment policy

The principal source of income was from membership subscriptions received and by various donations. Members of the executive committee and others, including professionals, give their time voluntarily to the charity and often bear some of the incidental postage, stationery and travelling expenditure personally.

Income received is utilised against the principal objectives and the running costs of the charity.

Total income during the year amounted to £42,427. Direct charitable expenditure amounted to £32,146. To the surplus of £10,281 the charity's administration costs of £3,864 were deducted which leaves net incoming resources for the year of £6,417.

The amount of £2,641 being a gain on investments held, was added to the funds leaving a surplus of £9,058 to be carried forward. Funds brought forward from previous years totalled £40,285. Therefore total funds carried forward at 31 December 2004 totalled £49,343.

Full details of the financial results of the year are shown in the statement of financial activities on page 7.

There are no restrictions on the charity's power to invest. The investment strategy is set by the trustees and unrestricted funds are invested in interest bearing 14 day notice account.

Funds

All funds are unrestricted.

Reserves policy

It is the policy of the charity to maintain funds at a level sufficient to finance not less than twelve months of unrestricted expenditure and that this level of reserves is held throughout the year.

Risk management

The trustees actively review the major risks which the charity may face on a regular basis and believe that maintaining reserves at current levels, combined with an annual review of the controls over key financial systems, will provide sufficient resources in the event of adverse conditions. The trustees have also examined other operational and business risks faced by the charity and confirm that they have established systems to mitigate the significant risks.

Equal opportunities policy

Membership of the committee is open to any person from any background who is able to contribute to the running of the organisation or any special project undertaken by the charity and to all lovers of Wagner's Music.

No person is excluded from membership of the charity or the committee on the grounds of sex, race, colour, religion or disability.

Statement of trustees' responsibilities

The Trustees of the Wagner Society are required to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the movement of funds for that year. In preparing those financial statements, the trustees are required to:-

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and for safeguarding its assets.

I report on the accounts of The Wagner Society for the year ended 31 December 2004 which are set out on pages 7 to 11.

Respective responsibilities of trustees and the independent examiner

As described on page 5, you, the charity's trustees, are responsible for the preparation of the accounts; you consider that the audit requirement of section 43 (2) of the Charities Act 1993 (the Act) does not apply and that an independent examination is needed. 1. Accounting policies

a) Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective March 2000). In preparing the financial statements the charity follows best practice as laid down in the Statement of Recommended Practice "Accounting and Reporting by Charities" (SORP 2000) issued in October 2000 and SORP Update Bulletin 1 issued in December 2002.

b) Tangible fixed assets for use by the charity and depreciation

Tangible fixed assets for use by the charity are stated at cost less depreciation.

Depreciation is provided at the following annual rate in order to write off each asset over its estimated useful life:-

d) Donations and investment income

Donations and investment income are accounted for when received.

e) Value added tax

Costs are inclusive of input value added tax not recoverable by the charity.

f) Taxation recoverable

Taxation recoverable is accounted for in the year in which it is receivable.
